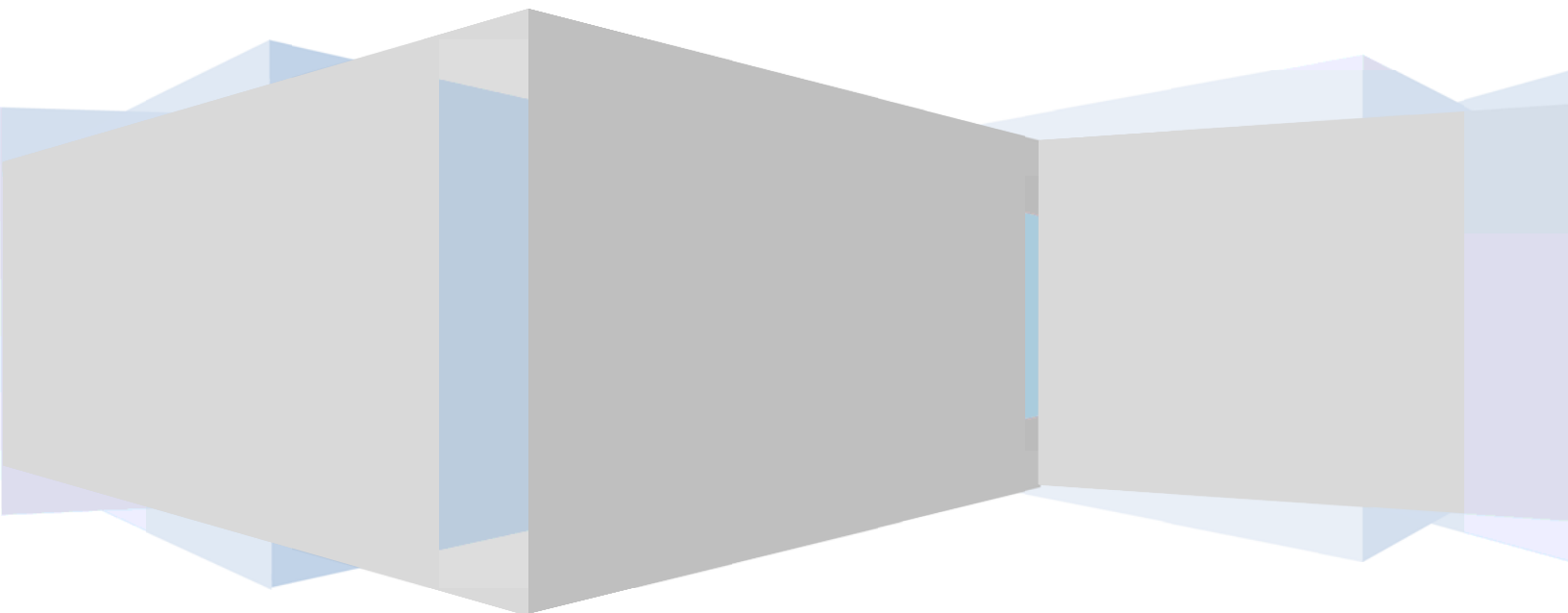

There are 18 RBPS that range from securing the site, to training, recordkeeping and coordinating emergency response and crisis management. ASI can advise you and assist your firm in developing measures that satisfy the RBPS and can result in “layers of protection” and individual measures that may help a facility meet more than one RBPS. ASI professionals are experts at designing cost-effective, resource efficient, well-organized plans that document coordination among existing plans, incorporate new measures needed to fill CFATS-specific gaps and meet



your compliance needs. We have written security and emergency response plans for a wide variety of industries.
